Description

The Porter-Aue House is located in the Village of Clinton at 2798 North Street on Lot 38. The nominated property is situated on the south side of North Street. Residential dwellings are situated directly to the east and west of the Porter-Aue House. The house's setback is approximately 20 feet from street. The house is located one block north of Main Street and 350 feet east of the Ohio & Erie Canal. Many of the houses near the Porter-Aue House date from the late nineteenth and early twentieth century and are similarly modest in size and scale (photos 21-24).

The house is the only contributing resource within the nominated area. The garage, south of the house, is considered non-contributing because its construction date, 1960, occurred outside the period of significance for the property.

Built in 1846, the house is a wood-frame, side-gabled, New England One-and-a-Half, Greek Revival (photo 1). The house has a rectangular plan with a one-story, shed-roof rear addition along the south/west section of the house (photo 5 and 6). There are no visible chimney stacks in the original core section of the building. One exterior chimney is located along the south elevation of the house (photo 6).

The façade of the house has three bays with the main entry door located in the center (photo 1). The house is clad with wood clapboard siding with corner boards and the roof is covered with asphalt tab shingles. The entablature along the eave oriented elevations contain a wide frieze panel and architrave, and the gable ends have broad cornice returns (photo 2).

The house contains a hipped-roof, wraparound porch along the north and west elevations (photos 1 and 4). The porch is supported by round and square columns and appears to have been part of a Colonial Revival update during the 1920s. There are two doors located on the west side of the house (photo 4).

Full size windows are one-over-one, double-hung sash and contain plain surrounds and wood shutters (photo 2). The Porter-Aue House also has a large, 9 light, picture window on the south (rear) elevation (photo 6). The basement windows are single light fixed.

The house has a rough-cut, sandstone rubble foundation and contains a full basement under the core section of the house (photos 8 and 9, figure 3). A crawl space exists under the 1920s one-story addition along the south side of the house. The addition's foundation is constructed of structural clay tile block.

The basement floor is poured concrete. A basement bulkhead door is located in the southwest corner of the basement (photo 13). The exterior bulkhead door is concealed within the floor of the southwest end of the porch.

A large, hand-hewn summer beam $(9"x\ 11")$ spans the length of the basement (photo 12). Many of the other wood floor beams still retain tree bark (photos 10 and 11). A set of wooden stairs, in the center of the basement, lead to the first floor.

The interior of the house includes original wood trim with molded lintels, baseboards, and sills. All of the wood trim is plain-faced. All of the interior doors are two-paneled and

appear to date from the original construction of the house (photos 17-19).

A steep set of stairs, located in the center of the plan, lead from the first to the second floor (photo 20). Doors on the second floor are "board and batten" and contain box, or rim, locks with keeper latches (photos 14-16).

A concrete walkway leads to a noncontributing garage that is located on the southwest section of the lot. The gable-roofed, wood-frame garage is clad with wood novelty siding and the roof is covered with asphalt tab shingles (photo 7). The building faces the rear alleyway and was built outside the house's period of significance.

Statement of Significance

The Porter-Aue House meets the registration requirements for properties eligible under Criterion C: Architecture as specified in the <u>Canal</u>, <u>Railroad</u>, and <u>Industrial Resources of Clinton/Warwick Multiple Property Documentation Form (Clinton MPD)</u>.

The Porter-Aue House is significant under Criterion C for representing a building that embodies the distinctive characteristics of type, period, or method of construction. The house is a New England One-and-a-Half, a building type identified in the Clinton MPD as significant.

The Greek Revival style is indicative of the influence of the opening of the Ohio & Erie Canal on the growth of the community. The New England One-and-a-Half in the Greek Revival style is strongly associated with the northeast Ohio building tradition. These building styles were extended to the Clinton area, in part, by the construction of the Ohio & Erie Canal.

There are only two New England One-and-a-Half, Greek Revivals in the <u>Clinton MPD</u> study area, and the other building, the Rhoads-Harter House, has experienced substantial alterations to its massing and fenestration patterns that have compromised its historic integrity. Within the Clinton area, the Porter-Aue House represents the most intact example of a New England One-and-a-Half.

Moreover, the modest Colonial Revival porch is expressive of the impact of industrialization on the canal village of Clinton. As the <u>Clinton MPD</u> notes, many of Clinton's Greek Revival style houses received Colonial Revival updates, reflecting the increasing influence of industrial prosperity in the community.

Historical Background

Like all the land in Franklin Township (Summit County), the U.S. Government originally owned Pumroy Lot 22. The entire township was created out of the Congress Lands. With the completion of the Ohio & Erie Canal in 1832, the land directly east of the canal prism became a prime area of commercial development.

In 1837, William and Francis Pumroy purchased a large parcel of land in Section 35 of Franklin Township east of the Ohio & Erie Canal and south of the Village of Orradeen, which was founded in 1835. The brothers named the area the Village of Pumroy, divided it into approximately 70 lots and quickly began to sell property.

In 1845, William Pumroy sold lot 38 to James Patterson and the following year he sold the property to John Stotler. According to the Summit County Tax Auditor's Duplicates, Stotler constructed a frame house on lot 38 in 1846. Stotler only retained ownership of the house for one year, selling it in 1847 to William Porter.

Porter, a day laborer in the Clinton area, owned the house for approximately 20 years. Circa 1870, William Aue purchased the house. The 1850 US Census, Schedule of Population lists Aue as a boatman and in the 1860 Census he is listed as a day laborer. However, the 1883-84 Akron City Directory notes that Aue was a boatman on the O&E Canal.

By 1910, Jacob and Anne Burgy acquired the house from Aue. Two years later, Jacob, his daughter Daisy, and two of her children Elizabeth and William, were killed in a fatal train accident.⁴ Anne would retain ownership of the house for a few more years and eventually sold the property to Willis Fye circa 1920.⁵

The house has remained in the Fye family ever since that period. The Porter-Aue House also received a number of Colonial Revival updates during the Fyes' ownership.

Between 1916 and 1927, a hipped roof porch was added along the north and west elevations of the house and the one-story, shedroof, rear wing was added to the building to serve as the new kitchen. Both of the alterations appear to have occurred prior to 1927 and each is represented on a 1927 Sanborn Insurance Map. The noncontributing garage situated at the southwest section of lot 38 is not represented on the 1927 Sanborn Map (Figure 1).

The Fye Family has remained in the Clinton community since the early twentieth century. Willis C. Fye worked for Firestone Tire

and Rubber Company in Akron, Ohio and eventually served as Mayor of the Village of Clinton from 1942 to 1945. The house is currently owned by Lawrence Fye, Willis' son.

Criterion C: Architecture

The Porter-Aue House is a significant example of distinctive construction practices associated with the Village of Clinton's "Canal Era" as defined by the <u>Canal, Railroad, and Industrial</u> Resources of the Clinton/Warwick Multiple Property Documentation Form. The Porter-Aue House also contains elements of the Colonial Revival style, which is associated with the "Industrial Boom Era."

Even though the Porter-Aue House is a modest, New England One-and-a-Half , it retains significant architectural elements of the Greek Revival style, a building style directly associated with Clinton's "Canal Era." The house has wide entablatures, cornice returns, and corner boards. The façade of the structure has a blind half story under the eaves, which is a common treatment for a New England One-and-a-Half.

The New England One-and-a-Half is a building type strongly associated with Ohio's Western Reserve "New England Extended" building tradition. Steve Gordon's, How to Complete the Ohio Historic Inventory, notes that the New England One-and-a-Half building type is most commonly found in areas that were settled by New Englanders. As settlers migrated to Northeastern Ohio

from New York and New England they transported the Greek Revival style to the Western Reserve. But, as the Clinton MPD illustrates, a majority of the settlers in the Clinton area migrated from the Pennsylvania region and were native German/Pennsylvania Dutch. Additionally, the Clinton area was initially part of the Congress Lands. The predominance of Greek Revival canal era buildings demonstrates the significant impact the opening of the Ohio & Erie Canal had on the development of the Village of Clinton.

Nearly all of the extant canal era structures are Greek Revival and were built after the opening of the O&E Canal in 1827. The built environment strongly suggests that the canal transported ideas and building traditions, as well as passengers and freight.

Moreover, the Porter-Aue House appears to be an example of canal era worker housing in the Village of Clinton. William Porter was listed as a day laborer on the O&E Canal. William Aue, a subsequent owner, also worked as a day laborer in Clinton. The 1883-84 Akron City Directory notes that Aue worked as "boatman on the canal." Because of the modest nature of the New-England-One-and-a-Half it is reasonable to conclude that the building type served as housing for workers associated with the O&E Canal.

Historical Integrity

The historical integrity of the Porter-Aue House is well preserved. The nominated building has a high degree of integrity of design, still retaining its defining features, such as wide entablatures, cornice returns, end boards, and massing. Evidence of integrity of materials includes the wood clapboard siding and wood stylistic elements, which also evidence a high degree of workmanship. The house is in the same location it was during its period of significance (1846-1927), experienced no significant alterations to its profile and its effect in communicating its historic function as a residence. The small town setting surrounding the nominated property provides integrity of setting, feeling, and association with Clinton's Canal Era.








FIGURE THREE



SUMMIT COUNTY, OHIO



SUMMIT COUNTY, OHIO







FIGURE EIGHT
