Describe present and historic physical appearance.

250 College Street is a two-story detached wood frame dwelling built in 1935. The front elevation faces south, parallel to High Street, and is set back well over 250' from its lot lines in parklike surroundings. The house represents a Colonial Revival interpretation of early Greek Revival style architecture in Hudson. The slope of the front gabled roof is very shallow. The facade has a symmetrical, temple-like appearance with four full pilasters dividing the facade into three bays. Wide cornice trim creates a pronounced pediment in the gable end. The front entrance has a full entablature with pilasters, and the recessed door is surrounded by a transom and sidelights, made up of small, rectangular panes of glass. There is a lunette in the pedimented front gable. The windows are 12/12 double hung on the first story and 6/6 on the second. A side gabled wing with wall dormers on the front roof slope and a shed roofed porch complete the design on the east side.

The interior rooms open from a center hall running front to back, the living room to the left, kitchen and dining room to the right. The original six bedrooms on the second floor have been remodeled into four. The floors and trim are oak. In 1987, an attached garage was converted to use as a family room on the northeast corner of the house; a free standing garage was built the same year at the northeast corner of the lot. (non-contributing)

The lot is wooded and large and is situated at a point where College Street narrows into private roads. The land on which the house stands was once part of a fourteen acre holding of Simeon Porter, whose house stood directly west of this property. When his house was destroyed by fire in the mid-nineteenth century, he gave the land to his brother, Orin Porter, who built his personal residence, 240 College Street, on the west section in 1861. A portion of the remaining land was bought by J. W. C. Corbusier in 1917 for the construction of 226 College Street; the northeast section was bought by Robert and Grace Izant in 1935 as a site for their Colonial Revival house at 250 College Street.

There have been no visible changes to the exterior of the house since its construction. The alteration of the garage into a family room has made no visible changes other than to the door.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

250 College Street is significant under Criterion B, for its association with Grace Goulder Izant, journalist, author and historian, for 49 years; and under Criterion C, as embodying distinctive characteristics of a type and style of architecture which gained favor through the efforts of a native Hudsonite, James W. Ellsworth, and which has remained the prevailing architectural style for Hudson up to the present. It has retained integrity of location, design, setting, materials, workmanship, feeling and association, being little changed through the years. Locally, Grace Goulder Izant is of exceptional significance for her local and regional literary and journalist contributions. Grace Goulder Izant, the first owner, was born in Cleveland in 1893 and graduated from Vassar College in 1914. Following her school years, she served with the YWCA in France during World War I. She was married in 1924 to Robert Izant, a newspaperman with the Cleveland Plain Dealer. From 1940 until 1969, she wrote a series of articles for the Plain Dealer on Ohio history which were later enlarged into two best selling books, This is Ohio (1953) and Ohio Scenes and Citizens (1964). She soon became well-known as a journalist, author and historian. The next few years of her life were devoted to the research and writing of John D. Rockefeller: The Cleveland Years (1972), a book which has become a standard reference book for those historic times. Her final book was Hudson's Heritage (1985), stories of pioneer years in Hudson, published after her death. The book, according to the Hudson Heritage Newsletter, was the closest to her heart: "Bringing to it her knowledge as a historian of Ohio, she lifts the story beyond the limitations of local history and makes it illuminate an entire region and time." For Hudson's Heritage, she received the Florence Roberts Head Award from the American Association of University Women in 1986. She was the first woman to receive the Governor's Award for advancement of the prestige of the state; she was honored by an award from the New England Society for historical writing; she received citations from the American Association for State and Local History, the Ohio Historical Society, the Western Reserve Historical Society and the Ohioana Library. She was inducted into the Ohio Women's Hall of Fame in 1982. She died in 1984.

Colonial Revival style was brought to Hudson, Ohio by James W. Ellsworth, a native of Hudson, in the early 1900s. Colonial Revival had become a nationally popular style, partly due to the 1893 World's Columbian Exposition. The house at 250 College Street is an interesting Colonial Revival interpretation of Greek Revival style architecture as it appeared in the Western Reserve. Through its exaggerated upright and wing plan; its symmetrical temple front, with pilasters and unbroken pediment; and in its entry with full entablature and recessed doorway, this house reflects the stylistic adaptations of the early local architecture. This house is a superb example of the style and belongs to Property Type I, Domestic and Institutional Architecture, 1925/1940, relating to Historic Context Statement 5, Exurbia, of the Multiple Property Documentation.
